### Center Forward Immigration Poll Findings and Recommendations from a Nationwide Telephone Poll of Likely Voters March 2021

## Survey Methodology

ALG Research conducted a combined telephone and text-to-web survey of N=800 likely 2022 general election voters nationwide.

 $\succ$  Interviews were conducted March 9 – 14, 2021.

➤ 38% of all interviews were conducted via cell phone and 29% were conducted via text-to-web.

The margin of error for the sample is +/- 3.5 percentage points at the 95% level of confidence. The margin of error for subgroups varies and is higher.

## Key Findings


- There is broad support for legislation that would create an earned path to citizenship for Dreamers, TPS recipients, and farmworkers and other essential workers.
  - A majority of voters across partisanship support the legislation, and support is strong across race and education.
- Although voters support the individual components of the legislation, support for providing protections for Dreamers is especially strong -- 8-in-10 voters support a path to citizenship for Dreamers, including 59% that *strongly support* these protections.




#### **CURRENT SUPPORT FOR LEGISLATION**

Support for the legislation package is strong, with 3-in-4 voters supporting, and half of the electorate *strongly supporting*.

Do you support or oppose legislation that would create an earned path to citizenship for undocumented immigrants who were brought here as children, people who are contributing and working here legally due to war or natural disaster in their home countries, and farmworkers and other essential workers?




# A majority of voters across partisanship support the package, including 54% of Republicans.



#### Support for the legislation is high across racial lines.

The legislation has 2/3 support among GOP-leaning white non-college voters and is stronger among white college grads.



### A majority of the electorate supports the individual components of the legislative package. The strongest support is for getting Dreamers and TPS recipients a path to citizenship.

Groups Congress is considering protection from deportation and path to citizenship

Undocumented immigrants who were brought to the U.S. as young children, also known as Dreamers, who graduate high school and either attend college, get a job, or join the military.

People who have been legally working and contributing in the U.S. to escape war or natural disaster in their country and have been unable to safely return.

Undocumented farmworkers and other essential workers.


## Messaging on Dreamers is very compelling, with a majority of voters finding this a very convincing reason to support the legislation. Voters also find messaging on TPS and the citizenship requirements to be convincing. The "Rules" message is top-testing among Republicans.


# Negative messaging tests with much lower intensity than positive messaging.

<b>[LAWS]</b> The U.S. is a nation of laws, and we shouldn't reward those who have cheated the system and cut in line. If immigrants broke the law to enter our country, we have to assume they will break other laws as well. People who want to immigrate here should follow the law and get in line, and those who try to enter illegally should face consequences.	40	15	69	28	42	17	43

Across the board, support for the legislation remains stable after positive and negative messaging.



A majority of voters across partisanship – including 53% of Republicans – continue to support the legislation after negative messaging.





#### RECOMMENDATIONS

### Recommendations

- Messaging should highlight this legislation helps Dreamers, people who America is the only country they've known.
  - There is overwhelming support across the electorate for providing protections for Dreamers.
  - A majority of voters find messaging on Dreamers to be a very convincing reason to support the legislation.

• In communications targeted to swing voters and Republicans, reassure them that these groups will have to follow the rules to earn citizenship.
